Background Information:

A Letter from the Misty Mountains Nature Park

Welcome to the Misty Mountains Nature Park. We are a privatelyowned park located in the Sierra Nevada Mountain Range in Northeastern California. We offer limited space for visitors. Please call ahead and make a reservation for one of our cabins. We try to minimize human impact by allowing small groups of people to enjoy this beautiful area. We believe in low impact activities in order to preserve a relatively untouched area. We encourage you to practice **Leave No Trace** while in the park. The park has many outdoor activities to offer including fishing, hiking, camping, and wildlife viewing.

There are six main locations in the park:

- 1. Lodge: check-in for information
- 2. Cabins: four beds in each cabin
- **3.** Fish Lake: kayaking, canoeing, and fishing are permitted
 - a. See fishing regulations and permits at lodge
 - b. No motorboats allowed
- 4. Curvy Creek: fishing and camping is permitted
- 5. Misty Mountains: one trail is maintained for hikers
 - a. Camping is permitted
- 6. Pine Forest: wildlife viewing is permitted
 - a. Please do not disturb the animals
 - b. Please do not feed the animals
 - c. No flash photography

Leave No Trace is a practice where a person does not leave any sign or trace that they were somewhere in nature.

Perspective is a person's views on an issue which might affect their position in life.

Deforestation is the clearing or cutting down of trees.

Animal Displacement occurs when habitat is destroyed by human activities or natural disasters.

Impermeable Surfaces are human made surfaces that increase **run-off** and decrease water absorption into the ground.

Run-off is toxic or polluted water that empties into bodies of water.

Pollution is human made trash, debris, and waste that enters the environment.

Environmental Impacts are impacts that affect the areas in and around something.




Over the years, the park has become one of the most popular vacation spots for outdoor enthusiasts because of the flourishing ecosystems. In the park you will likely see...

The two entities have decided to hold a town hall meeting and cast a vote amongst the people of Misty Mountain. Town Hall Meeting Activity

Instructions:

It is time to hold the town hall meeting. This meeting will decide whether or not the resort will be built or the nature park will remain the same with new ownership. There will be different positions during this meeting.

- 1. First you must designate one person to be the town hall judge. This person will hear out everyone's argument as to why they are for or against the park.
- 2. The other positions are the companies, clubs, interest groups and agencies that are either for the resort or against the resort. Present the list of groups to your family or friends. Allow each person to choose two groups, one group that is for the resort, and one group that is against the resort.
- 3. Once everyone has chosen their groups, write the groups down on a piece of paper, cut them out, and place them in a bowl.
- 4. Now, have each person blindly pick one piece of paper out of the bowl. Once everyone has a group, they must form an argument from their **perspective**, arguing either in favor *or* against selling the land to the development company.
- 5. Start by allowing one person 5 to 10 minutes to present their group's argument. Once they have presented their argument, leave 1-2 minutes for others to respond.
- 6. Repeat this process until every person (except the judge) has presented.
- 7. Once everyone has presented their argument, the judge should ask all groups to close their eyes for a blind vote. Each person who is in favor of development will raise their hand. Those who are against development will keep their hands down.
- 8. The judge will tally the results. If most of the townspeople voted in favor of development, the land will be sold to MTDC. If most of the townspeople voted against development, the town of Misty Mountain will purchase the land and the Misty Mountains Nature Park will continue their business, as usual.

If there is a tie—meaning that an equal number of townspeople voted for and against development—the judge should allow an additional 20 minutes for individuals to represent their groups, in an effort to convince one of the groups to change its vote.



Consider the following questions:

How does the final decision affect different groups?

If the final decision is to build the resort, what <u>environmental impacts</u> might occur?

Which group or groups from the list above might benefit the most from the resort not being built? Why?

Junk Drawer Debrief

Here at Sierra Nevada Journeys, we often discuss our thoughts and feelings following an activity. Debriefing is a good way to analyze the strategy and purpose of the activity with your friends and family.

Instructions:

- 1. Find a junk drawer in your house and grab a handful of items. Get as many items as there are people.
- 2. Circle up and place the items in the middle of the circle.
- 3. Take a minute to look at the items and then pick one that you think relates to the way you feel, your thoughts, the strategy or the purpose of the activity.
- 4. Once everyone has their item, go around the circle and give everyone the space to speak about their experience and item.
- 5. Once everyone has spoken, try to reach a conclusion about the main point of the activity.





Example: I think the rock represents forming a solid argument and sticking with it.

Consider the following questions:

Do you think the town hall activity is a good way to make major decisions? Why or why not?

Do you think building a resort would be a positive thing for the local economy (market)? Why or why not?

Do you think it is important to accept other people's perspectives? Why or why not?
